Patient information

Free NHS prescriptions for cancer patients



Unless you already receive free prescriptions, all cancer patients in England are eligible for a Medical Exemption Certificate. Cancer patients undergoing treatment for cancer, the effects of cancer, or its treatment can obtain the application forms from their GP or oncology clinic. This leaflet explains how to apply for the exemption certificate for patients with cancer.

How do I apply for an exemption certificate?

You can apply for an exemption certificate by collecting a 'FP92A' form from your GP surgery or oncology clinic. You will need to fill out parts 1 and 2 and your doctor (GP or oncologist) or authorised member of the team (practice nurse or oncology nurse) can sign to confirm the information is correct. You should then send the form to the following address below or ask your GP surgery to send it in a prepaid envelope. The medical exemption team aim to process all applications for an exemption certificate with a 3-day turnaround.

What should I do before my certificate arrives?

Before your exemption certificate arrives, whenever you pay a prescription charge, remember to ask your pharmacist for an FP57 NHS receipt and refund claim form. You will have to send these back to the authority (address above) to reclaim expenses paid.

How long will my certificate be valid for?

The certificate will last for five years or until your 60th birthday whichever comes first. Once your certificate has expired, you can apply for a new one. The NHS Business Service Authority will remind you before the expiry date. If you require more treatment related to your cancer after five years you will be eligible to re-apply.

What sort of medication does the certificate cover?

GPs and oncologists should issue an exemption certificate if you need medication to treat:

- Any diagnosed cancer (including drugs prescribed after curative treatment e.g. Tamoxifen and hormone replacement therapy)
- The effects of cancer (including palliative care and changes to mental health since a cancer diagnosis)
- The effects of cancer treatment (including the effects of current treatment or previous treatment. They include the side-effects of chemotherapy drugs and the late effects of radiation)

Does the certificate cover other medication?

Yes, exemption certificates cover all prescriptions, not just those relating to cancer but not NHS wigs, although there may be other ways to receive help with this such as NHS low income schemes and other recipients of tax credits, benefits or allowances.

Is there anything else I need to know?

If you have a medical condition which may entitle you to a Medical Exemption Certificate, you should also inform the Drivers Medical Group of the DVLA (Drivers and Vehicle Licensing Agency) of your condition, as it may affect your fitness to drive.
